TERMS AND CONDITIONS

To make your time with Antique Limousine Service of Utah (Antique) an enjoyable one, it is necessary that you, the purchaser (Purchaser), agree to and abide by the following:

Applicable Laws and Liability

Antique will strictly enforce all applicable state, local and federal laws and regulations as they pertain to the rendering of this limousine service. No contraband and/or smoking of any kind are allowed in the vehicle. No drinking and/or possession of alcoholic beverages of any kind are allowed in the vehicle. Eating and drinking (non-alcoholic drinks) in the vehicle is prohibited without the permission of the chauffeur. Antique, its employees and its subcontractors shall not be liable for any injuries, property damage or any other kind of damages resulting from horse playing, illegal and/or inappropriate conduct while the vehicle is in motion, at a standstill, or when entering and exiting the vehicle. The Purchaser shall be responsible for the conduct of the guests in the vehicle and Purchaser shall be liable for any resulting damages caused by such guests.

In addition, in the sole discretion of the chauffeur, the chauffeur may terminate the contract if the Purchaser and/or guests engage in such inappropriate conduct or if the chauffeur feels that safety may be compromised in any way. In such event, all balances will be immediately due and payable. Due to legal requirements, there shall be no additional passengers unless previously agreed upon. The number of passengers allowed in the vehicle shall be no more than the specified number in the contract or limited to the vehicle passenger capacity it is designed to carry.

Damage to Vehicle

At the chauffeur's sole discretion, the Purchaser agrees to accept a minimum financial responsibility of \$350.00 for any damage to the vehicle caused by Purchaser and/or any passenger. This shall include, but not be limited to, damage resulting from improper use of the vehicle and its contents, damage to audio/video equipment, lighting, interior/exterior of vehicle, including upholstery. In addition, this minimum \$350 damage fee shall also include costs of cleaning the vehicle resulting from excessive mess, spillage, or sickness in the vehicle caused by Purchaser and/or any passenger. In the event of such damage, Antique will provide Purchaser proof of such damage and Purchaser agrees to pay the actual costs of repair/cleanup of the vehicle, or the minimum \$350 damage fee, whichever is higher.

Lost Items

Antique recommends that any and all personal valuables be removed from the vehicle when unattended. Antique shall not be liable for any lost, stolen, or damaged items, including without limitation, computers, jewelry, clothing, luggage and cell phones. In the event you are missing an item, we will make a reasonable attempt (but will not be obligated to do so) to return the item to you in a timely manner, if we are able to locate such item in the vehicle.

Overtime

Antique cannot guarantee the availability of overtime, although we will make reasonable efforts to accommodate your schedule changes. The base price of the limousine service is simple transportation and is based on immediate pickup/drop-off and no wait time is included. If overtime is desired, this must be mutually agreed between Purchaser and the chauffeur and will be billed at the rate set forth on page 1 of this Contract.

Payment, Deposit, No Show Policy

Except as set forth below, all deposits are non-refundable. If after paying the deposit, Purchaser fails to show up for the service or to call and cancel as set forth below, Purchaser shall be liable for the entire balance of the Contract amount. Purchaser may cancel this contract only upon 48 hour prior notice to the date of pick up and in such event Purchaser shall only be responsible for payment of the

deposit fee. If Purchaser cancels within 48 hours of the pickup date, Purchaser shall pay the deposit fee and remaining balance in full. The only exception to the above is in the event Antique must cancel due to inoperability of the vehicle, severe and inclement weather, and/or other emergency. In such event, Antique will notify Purchaser as soon as possible of such cancellation and Purchaser shall be entitled to reschedule the service, or receive a total refund (including deposit) of monies paid.

The authorized cardholder for the given credit card is responsible for the payment of the total amount. Cash is accepted, but no personal or business checks will be accepted. The credit card holder hereby gives authorization to use the credit card information over the phone/fax/internet in combination with the signed Contract. The 25% deposit must be paid by credit card prior to pick up. Within the Salt Lake Valley, the service will begin upon pick up and the remaining balance (including gratuity and additional fees) shall be due and payable at the end of the service. If the service is outside the Salt Lake Valley, the service will begin when the vehicle leaves Antique's property and the remaining balance (including gratuity and additional fees) shall be due and payable at the end of the service.

In the event Purchaser does not comply with the above polices, Purchaser agrees that Antique can charge Purchaser's credit card for any and all outstanding amounts due and owing to Antique for limousine services rendered under this Contract.

Uncontrollable Circumstances

Antique shall not be held liable for late arrival, nor for any loss, damage, or injury whatsoever, caused by (without limitation) any act of God, traffic delays, construction delays, traffic accidents, breakdown of vehicle, incorrect pickup and drop-off information, and any other event beyond Antique's control.

Entire Agreement

This Contract contains the entire agreement between Antique and Purchaser and supersedes any and all prior agreements, written or oral, with respect to the services herein. There are no verbal understandings, agreements, representations or warranties between the parties which are not expressly herein set forth. This Contract may not be changed or terminated orally but may only be changed by an agreement in writing signed by both parties.
